

SUPA QUICK COMPETITION TERMS & CONDITIONS

1. By entering the Win with SA Taxi Rewards competition, all participants agree to be bound by these terms and conditions.
2. The competition is organised by Supa Quick, a wholly-owned subsidiary of Bridgestone South Africa Retail (Pty) Ltd.
3. In order to be eligible to enter the competition, a participant:
 - 3.1. Must be at least 18 years old and residing in the Republic of South Africa;
 - 3.2. Must have purchased 2 or more Bridgestone 613V 195/R15C sized tyre from Supa Quick; and
 - 3.4. Must be an SA Taxi rewards member.

There is nothing more than what is set out above and 11 and 12 that a participant is required to do other.

4. All participants who meet the eligibility requirements set out above will be automatically entered into the competition.
5. Entrants are only eligible to win once during the competition period.
6. The following persons and entities are not eligible to participate in the competition:

 - 6.2. directors, members, partners, employees, agents or consultants to the advertising and promotion agencies of Supa Quick and their spouses, life partners, immediate family members and business partners; and
7. The competition commences on 01 August 2020 and closes on the 31 of September 2020 at 17:00. Any entries received after the closing date will not be valid and will not be considered.

8. Ten winners will be randomly drawn and each winner will receive a R1000 (“prize”), which will be paid directly into his/her SA Taxi Rewards membership account.
9. The judges’ decision is final and no correspondence in this regard will be entered into.
10. The prizes are not transferable. If, for any reason, Supa Quick cannot provide any of the prizes, Supa Quick will award an alternative prize (at its discretion) of similar value.
11. Each of the winners will be required to provide Supa Quick with proof of identification in the form of a copy of his/her identity document, passport or South African driver’s licence.
