

**WIN A PORSCHE COMPETITION (“COMPETITION”) BY SA TAXI DEVELOPMENT FINANCE PROPRIETARY LIMITED (“SA TAXI”, “WE”, “US” OR “OUR”)**

1. Who qualifies and how do participate in this competition
  - 1.1. Any customer (“you”, “qualifying customer” or “your”) of SA Taxi qualifies to participate in, and thereby receive an automatic and single entry into, this competition if he/she:
    - 1.1.1. is 18 years or older;
    - 1.1.2. is a South African citizen who possesses a valid South African Identification Document or Passport;
    - 1.1.3. **purchases a quality renewed minibus taxi** (“taxi”) from SA Taxi between the months of November and December from any premises administered anywhere in South Africa (including in Midrand (Gauteng), Polokwane, Cape Town, Johannesburg South and Durban) by any one or more of:

    - 1.1.4. takes delivery of the taxi anytime between the 1 November 2021 and 31 December 2021; and
    - 1.1.5. is not a director, contractor, agent, service provider, employee, consultant, immediate family member of a director contractor, agent, service provider, employee, consultant of, or otherwise closely associated with, SA Taxi.
  - 1.2. You will receive an additional entry if you:
    - 1.2.1. sign a monthly debit order authorisation to may monthly repayments for your taxi; and/or
    - 1.2.2. register to join and be a member of the SA Taxi Rewards program

    - 1.3.1. The competition does not apply to purchases of a taxi before the commencement of the competition term;
    - 1.3.2. The competition only applies to purchases of a taxi (as defined in 1.1.3 above) only;

    - 1.3.4. Offer valid on Quality Renewed Taxi purchases from 16 November 2021 to 31 December 2021.
