

SA TAXI REWARDS PROPRIETARY LIMITED ("SA TAXI") AND SHELL DOWNSTREAM SOUTH AFRICA (PROPRIETARY) LIMITED ("SHELL") – TOGETHER BEING "WE", "US", "WE" OR "PROMOTERS") FUEL COMPETITION 15 JULY 2022 – 11 SEPTEMBER 2022 ("COMPETITION")

1. Who qualifies to participate in this competition: The following persons qualify for this competition, all members ("you", "your" or participant") of SA Taxi who:
 - 1.1. buy any fuel from Shell's fuel stations in Republic of South Africa according to these terms and conditions; and
 - 1.2. all members of SA Taxi who swipe their SA Taxi loyalty cards after purchasing any fuel from Shell's fuel stations in Republic of South Africa according to these terms and conditions.
2. Prize
 - 2.1. If we select you as a winner in terms of these terms and conditions you will receive 1 (one) voucher in each week during which you qualify to win in a prize in terms of these terms and conditions. For this purpose you may select any one of the following vouchers:
 - 2.1.1. a R30 Steers/Nando's/Debonairs/Mcdonald's/Hungry Lion food voucher;
 - 2.1.2. a 250MB all network data voucher;
 - 2.1.3. a R20 car wash voucher;
 - 2.1.4. a R30 soccer ticket
 - 2.1.5. a Movie ticket
 - 2.1.6. a 35% discount Hi Q services voucher; or
 - 2.1.7. a 35% discount Hi Q battery voucher.
 - 2.2. If you win in terms of this competition SA Taxi will notify you by SMS (using the contact details registered in relation to the winners' SA Taxi loyalty card) within 2 (two) days after the draw, and you will receive a voucher by SMS which you may redeem/use at any Steers, Nando's, Mcdonald's, Hungry Lion or Debonairs or HiQ stores or participating car wash outlets, the names of which (car wash outlets) we will notify you from time to time by SMS.
3. How the competition works: In order to win you must:
 - 3.1. spend at least R2000 (two thousand Rand) (once-off or accumulatively) on any fuel from Shell's fuel stations in Republic of South Africa ("eligible transaction") during the week (between Monday and Sunday) in which we conduct a draw in terms of this competition; and
 - 3.2. swipe your SA Taxi loyalty card in respect of the eligible transaction.
 - 3.3. **For the sake of clarity each entry into the Competition comprises each qualifying transaction at a SHELL fuel-selling site in the Republic of South Africa, conducted by you or someone acting on your behalf and spending R2000 or more on any type of fuel AND swipes your SA Taxi loyalty card immediately after conducting that qualifying purchase. Therefore, such purchase shall only qualify as a qualifying entry if you have also swiped your SA Taxi Loyalty card in respect of that transaction.**
4. Important dates – the following are the dates which we have designated for this competition (**We may change the dates from time to time without first consulting you. We may also extend the competition term or shorten it in our sole and exclusive discretion**):
 - 4.1. The competition will commence on 15 July 2022 and end on 11 September 2022 ("competition term"). **For the purpose of this competition, we will not consider purchases taking place before 00:00 on 15 July 2022 or after 23:59 on 11 September 2022;**
 - 4.2. Since the competition starts on a Friday, the data/information that we require to conduct the first week's draw will include data/information for 15 July, 16 July and 17 July 2022.

- 4.3. SA Taxi is responsible for conducting the draw, which it will conduct on the third (3rd) business day following the end (Sunday) of each week of the competition term.
5. Consequences of participating in this competition and other applicable terms/rules– By entering into this competition (which you may only do in the manner we explained in 1 and 3 above) you agree, accept and consent (NOTE: You may withdraw your consent in writing to info@sataxirewards.co.za but free of charge any time) that:
- 5.1. SA Taxi (and/or any of its affiliates (entities the financial results of which are, or are required to be, consolidated into the financial records of SA Taxi Holdings Proprietary Limited and/or Transaction Capital Limited according to those entities' accounting policies from time to time) may use your personal information (such as your name and/or photograph/likeness etc.) and publish that information in its various internal/external media in relation to this competition and/or share it with organisations in cooperation with whom SA Taxi markets goods and/or services to you;
 - 5.2. SA Taxi and Shell may (in their sole and exclusive discretion) stop/cancel this competition or amend the terms and conditions as they deem appropriate and without first consulting you;
 - 5.3. these terms and conditions (as we may amend them from time to time during the term of this competition) are binding on you;
 - 5.4. in addition to 5.1, SA Taxi and/or its affiliates may use your names for marketing and sales purposes, including to understand your shopping habits;
 - 5.5. The Promoters, their associated companies, directors, officers and employees, contractors, agents and suppliers, representatives and affiliates are not responsible to you for any failure of transmission of information relating to your entry in terms of this competition or a failure to redeem your prize if you are we select you as a winner if such failure results from any technical error or another factor which is not caused by the Promoters or persons representing the Promoters.
 - 5.6. As far as the law allows, anything which we have not specifically mentioned in this document and in relation to the competition is hereby excluded.

For this purpose you will have no claim for any compensation or payment in respect of the use of his/her name or image unless we have used such personal information contrary to your consent or the applicable law.
 - 5.10. Subject to applicable law, SA Taxi's internal auditors are the appointed auditors for this competition. The Promoters reserve the right to appoint external auditors in their sole discretion and for any reason whatsoever.
 - 5.11. As far as the law allows, the Promoters shall only be responsible for those costs which these terms and conditions expressly say that the promoters will pay. The participant is responsible for (i) any and all applicable local taxes and fees for the eligible transaction and/or his/her entry to this competition or from the acceptance, receipt, use or enjoyment of any prize; and (ii) all other costs incurred by him/her, or arising directly or indirectly from, the participant's
